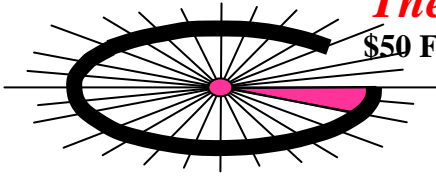

**Facilities:** There is a State Park entry fee (\$7.00in/\$10.00 out-of-state). Restrooms! We have mile marks, an unmanned water station, digital timing, and computer results by Greystone Electronics. Swim in the refreshing Farmington River.
