- III. Budget Session for 2023 Including Treasurer's Report

As of October 10 our account has a balance of \$127,048.71 Uncashed Checks \$445.00

Reconciled Balance \$ 126,553.71

\$128,986.00 <- Previous Balance. There is also a check with a \$50 discrepancy (\$1,450 actual vs \$1,400 cashed)

Continue discussion on 2023 budget and vote on acceptance

The budget is being revised upwards

INCOME

- MUT will remain a 0 balance (done as a service)
- J/O may be reduced participation is down, will probably come in as \$1,800.
- Outdoor Championships: is believed to be only \$3,000 from this, as the event is on the West Coast.
- Indoor Championship Entry Fees:
- Open Masters Indoor (Not currently a line item): Not a requirement, it is currently done as a service, because of very low participation and high costs. Would like to get a sanctioned event, perhaps as an open training ground. Or done as a series of 3 meets.
 - o Being assigned \$1000 in income expectations
- Club fees: Estimated to be the same
- Grants: \$5,000 repeats this year. We haven't spent it all, so we may not get another grant

This boost income to \$52,000 up from \$42,000 in prior year

EXPENSE

- XC and Grand Prix are remaining the same
- CT Cup and Members Only Race discontinued
- JO and Youth XC: Raising anticipated cost as most of the cost of was Portable Toilets and Labor, which have risen significantly
- Kept the same, though the discussion about hosting in Middletown is being floated.
- Outdoor Open Masters: The difficulty is finding a facility which can accommodate the throws. We are using \$2,500 as a place holder; falls middle of the field.
- Racewalking: \$500 entry
- National Convention: \$10,000 usually hits the target
- Membership Drive:
- Sanctions
- Officials / Youth Development remain the same

The proposed budget would result in a surplus.
